

# REQUEST TO ACTIVATE THE CONVENTIONAL WARRANTY

## Offer by ISOPAN IBERICA to Users of the Products ISOFARM

- The Conventional Warranty offered by ISOPAN related to ISOFARM range products (available - together with the relative General Conditions of the Conventional Warranty - in the ISOFARM Catalogue, and downloadable from the website <http://www.isopan.com> - hereinafter the “Conventional Warranty”) is reserved solely for purchaser end users of the products of the ISOPAN range (the “Clients”);
- The request to activate the Conventional Warranty attached thereto must be filled in and transmitted to ISOPAN directly by the end user Customer intending to avail itself of the Conventional Warranty for the ISOFARM purchased products;
- In the request to activate the Conventional Warranty the Client must specifically indicate the supply of ISOPAN products for which he/she is asking to activate the Conventional Warranty (the “Supply”);
- The request to activate the Warranty must be sent to ISOPAN in writing by the Client (together with a copy of the Environmental Questionnaire signed by the Client and by the seller he/she purchased to the Products from, if not ISOPAN) by registered letter with return receipt or by e-mail to [garantia@isopan.es](mailto:garantia@isopan.es), within 30 (thirty) days of the Product delivery date to the Client, certified by the Client by attaching a copy of the Delivery Note issued by the seller;
- Only Warranty activation forms with all parts duly filled in, with the Client’s double signature will be considered (signature also for specific approval of the general conditions) and accompanied by a copy of the Environmental Questionnaire, the purchase invoice and the Delivery Note. If any of the above conditions should not be met, the Conventional Warranty will not be effective, even if the Client sends the activation form to ISOPAN;
- The Conventional Warranty will cover SOLELY ISOFARM range Products purchased by the Client and specifically indicated in the activation form; it will not concern any other ISOPAN products possibly purchased by the Client, even if at the same time as the Supply;
- As the conditions, duration and content of the Conventional Warranty can vary significantly based on the different characteristics of the ISOFARM Products purchased by the Client, in case of Supplies related to two or more Product types of the ISOFARM range, the Client will have to fill in – for each type of ISOPAN Product in the Supply – a specific Activation Request (and related to each one ISOPAN will issue, in the right conditions, a specific Conventional Warranty);
